#### Sonoma County Sheriff's-Coroner's Office: The Resurrection of a Coroner's Office

The Sheriff's Office would like to take this opportunity to thank the Grand Jury for recognizing the work we have undertaken in recent years to improve the operation of the Coroner's Office. We sincerely appreciate the commendations listed in the Grand Jury Report.

#### **FINDINGS**

## F3. The future sale of the Chanate property makes it necessary to relocate the Connor's Office.

RESPONSE: The respondent agrees with the finding.

The Sheriff's Office welcomes the Grand Jury's acknowledgment of this impending issue.

#### **RECOMMENDATIONS**

# **R1.** The Board of Supervisors, working in conjunction with the Sheriff's Office and the Coroner's Office Lieutenant, identify a new location for the Coroner's Office and Morgue facility by December 1, 2020

RESPONSE: The recommendation has not yet been implement, but will be implemented in the future.

The Sheriff's Office is aware of, and concerned with, the looming need to relocate the Coroner's Office and morgue. At the time the Chanate Road property was first being contemplated for sale, the Sheriff's Office contacted the County's General Services Department with our concerns. We started with General Services as they are tasked with the responsibility for all County owned facilities. Conversations between the Sheriff's Office and General Services regarding the Morgue began in 2017.

In the Sheriff's Office Capital Project Request for the 2019-2024 General Government Capital Project Plan submitted to General Services on October 31, 2018, Sheriff's staff included the need for the relocation of the County Morgue Facility. We requested the County consider, in any County capital project planning, the results of the future Chanate property sale and the need to relocate the Sheriff's Coroner's Offices, including the Morgue. We requested that the relocation be considered when updating the Comprehensive County Facilities Plan and in the development

of a new County Governmental Center. This was followed up by the submittal of a General Services Project Request Form in December 2018.

The Sheriff ranked the Morgue Replacement project as its number one priority in the *Sheriff's Office Capital Project Request for the 2020-2025 General Government Capital Project Plan* submitted to General Services on December 3, 2019. In this submittal, Sheriff's staff indicated it was imperative that planning for a new facility begin in FY 20-21 to ensure a new facility is available prior to eviction from a new owner of the Chanate property.

The Sheriff and his staff have been working towards the goal of identifying a new location for the Morgue. With this type of capital project, the Sheriff's Office is completely dependent on County General Services, the County Administrators Office, and the Board of Supervisors for both project planning and prioritization and for funding. Despite our best efforts in the role we play with project planning, we do not believe this will be accomplished by December 1, 2020. We will continue to work diligently to communicate the vital and constitutionally required function of the Coroner's Office to our partners at the County. We look forward to working with them to accomplish this recommendation.
